I further agree to waive all benefits flowing from any California statute or the statute of any other state, which would otherwise limit the scope of this release and indemnification, including but not limited to Section 1542 of the California Civil Code which states:

"A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known to him must have materially affected this settlement with the debtor."
