In consideration of being granted membership, I hereby agree, now and in the future, to release and hold harmless AT, its members, sponsors, advertisers, and officers from any and all liability for any damage or injury to myself or a guest of mine which may occur during my participation in any AT ride, activity or event at any time, and this release shall apply to all future rides, activities and events without the necessity of my execution of waivers or releases for each such future ride, activity or event.

I shall not permit any guest(s) of mine to participate in any AT ride, activity or event at any time unless and until such guest(s) executes a written release of liability in favor of AT, its members, sponsors, advertisers and officers.

I understand, that this means, that I agree not to file any claims against AT, its sponsors, advertisers or AT Officers for any damage or injury, including but not limited to any personal property damage and/or personal injury resulting from my connection or involvement with any AT activities or events. I further agree to waive all benefits flowing from any California statute or the statute of any other state which would otherwise limit the scope of this release and indemnification, including but not limited to Section 1542 of the California Civil Code which states:

"A general release does not extend to the claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known to him must have materially affected this settlement with the debtor."

I understand that I have provided American Thunder with some personal information. American Thunder will be sharing this selected information with our sponsors so that they will be able to promote their businesses and activities. By allowing them to have this information you may be eligible to receive any discounts afforded to members of American Thunder.
